SELLING FRESH PRODUCE AND / OR PREPARED FOODS AT THE MARKET.

1. Have **FOOD-SAFE** level 1 Certification and include a copy of this document.
2. Complete "**Food Sales Application 2008**" and submit to Vancouver Coastal Health Authority.
3. Include a **list of all produce** and goods to be sold at the market this season, including a description of unique and exciting aspects of any Prepared Foods and creations for the Jury.
4. Varietal and seasonal information, as well as quantity is useful when attempting to keep a good balance of assorted product at market, and avoiding an over abundance of some products.
5. **Organic farmers** and food must submit documentation to indicate the type of classification and the governing body under which the products are certified. If uncertified, indicate the type of cultivation, and pest management practices if utilized if desired.
6. Friend farm documentation must be registered with the market manager, prior to the product being at market, for all fresh produce brought to market from a source other than the above mentioned farm or business. Complete and submit 'Friend Farm' forms for each alternate source of product. The annual membership fee must be paid on behalf of the other farm.

PAYMENT, GUARANTEEING AND CANCELLING SPOTS:

- Vendor fees must be submitted with application via Cheque or Money Order payable to 'Whistler Farmers' Market' on May 15th 2008.
- NSF Charges are \$20 per cheque.
- Pre-paid stall assignments will be guaranteed only until 10 am on market day.
- Vendors must attend the market from 10 am setup until 4 pm closing.
- Vendors who must cancel a market date are required to call the market phone by the Thursday, 10 am before market date. If an emergency should arise, please let the manager know ASAP regarding your absence.
- This is a rain or shine event.
- Vendor parking is in the gravel Day Lots, not on site.
